Participants or project teams can elect ongoing mentorship for a curricular project after completion of the **(Principles and Practice Workshop) or (Longitudinal Program in Curriculum Development)**. Each individual or team will have meetings with an assigned mentor to review progress and receive verbal feedback on each step of their project.

WHO SHOULD ATTEND

This activity is intended for scholarly educators in the fields of medicine, nursing, public health, psychology, and laboratory research, who have completed the 2-Day (Principles and Practice), ½-Day, or Longitudinal Program in Curriculum Development (or their equivalents).

- problem identification and general needs assessment
- targeted needs assessment
- goals and specific measurable objectives
- educational strategies
- development in implementation
- evaluation and feedback.
